<u>Pickup player list</u>: If you are not able to fill your roster, please check our City of Iona Sports Facebook page for players still looking for a team. Players must play at grade level or play up, but will not be permitted to play down a level. Practices are held at each coach's discretion. Game schedules will be available online and emailed to you when completed.

No Blocking. Blocking is defined as any interference with the defense.

Rules may change at Director's discretion. Please be compliant.


